
Please help me. The victim had contacted an outside agency asking them to have their gun removed from her house. The conservator also determined that the dog had not been neglected, and that the dog was a rescue dog that had not been mistreated. He stated that the dog was not dangerous and showed no signs of being aggressive. By the end of May 2012, the conservator had removed the guns from the house, and the victim had begun spending most of her time at home. By June of 2012, the conservator filed a motion to have the conservatee declared as an incapacitated person, stating that the victim had been unable to pay her bills and had threatened to harm herself. In support of the motion, the conservator stated that the victim refused to participate in therapy or to take medication to stabilize her mood. By August of 2012, the conservator filed a motion to terminate the conservatorship, stating that the victim was not incapacitated. By December of 2012, the victim had filed a motion to remove the conservatorship. She stated that she had been attending counseling and had a job. She also stated that she still owned the dog and that the dog was not dangerous. Court Hearing Summary At the hearing for the conservatorship to be terminated, the conservator submitted the victim's medical records as well as a report from the victim's psychologist. The psychologist's report stated that the victim had been referred to the psychologist as a result of her having a breakdown and having been hospitalized for several weeks.
